ORDER DENYING JEREMY ALCEDE'S EMERGENCY MOTION OBJECTING TO PROPOSED ORDER REGARDING SOCIAL MEDIA ACCOUNTS [Doc. No. 259]

For the reasons set forth in a Memorandum Opinion, which is entered simultaneously herewith, this Court finds that the above-referenced Emergency Motion should be denied in its entirety. Furthermore, after reviewing the record, the Court finds that it is not necessary to employ a neutral third-party court aide to determine which social media accounts are property of the reorganized Debtor. It is therefore:

ORDERED that the Emergency Motion is denied in its entirety; and it is further ORDERED that all relief requested by Jeremy Alcede is denied; and it is further

ORDERED that Jeremy Alcede shall immediately cease any activity, except that specifically ordered herein, with regard to or potentially affecting: (1) the Facebook Page currently entitled "Jeremy Alcede Entrepreneur" and formerly entitled "Tactical Firearms" (the Facebook Page); and (2) the Twitter account currently entitled "Jeremy Alcede" with the handle "@jeremyalcede" and formerly entitled "Tactical Firearms" with the handle "@tacticalfirearm" (the Twitter Account); and it is further

ORDERED that John Boyert, the general manager of the reorganized Debtor, shall, by 5:00 p.m. on April 7, 2015, send Jeremy Alcede a Friend Request on Facebook; and it is further

ORDERED that Jeremy Alcede shall, by no later than noon on April 8, 2015, accept John Boyert's Friend Request; and it is further

ORDERED that Jeremy Alcede shall, by no later than noon on April 8, 2015, make John Boyert an "Admin" of the Facebook Page by navigating to "Page Roles" under the Facebook Page "Settings," typing **John Boyert**, selecting "Admin" from the drop-down menu, and then clicking "Save"; and it is further

ORDERED that Jeremy Alcede shall, by no later than noon on April 8, 2015, change the password to the Twitter Account to a password that he will share with John Boyert by navigating to Settings Password, entering the current password in the "Current password" field, entering the new password (the New Password) in the "New password" field, entering the New Password in the "Verify password" field, and then clicking "Save changes"; and it is further

ORDERED that Jeremy Alcede shall, by no later than noon on April 8, 2015, send an email to **info@boyert.com** and to **rkincheloe@nathansommers.com** informing them (i.e. John Boyert and counsel for the Plan Agent) that the password to the Twitter Account has been changed and also providing them with the New Password; and it is further

ORDERED that Jeremy Alcede shall, by no later than noon on April 8, 2015, change the email address associated with the Twitter Account to **info@boyert.com** by navigating to Settings \rightarrow Account, replacing the email address currently in the "Email" field with **info@boyert.com** and clicking "Save changes," and entering the current password for the Twitter Account to confirm the change; and it is further

ORDERED that Jeremy Alcede may also change the Name and Handle of the Twitter Account before changing the email and password; and it is further

ORDERED that if Jeremy Alcede fails to take any of the actions required of him described above by the deadlines set forth above, then he shall be in contempt of this Order, and this Court will issue a bench warrant for the U.S. Marshals Service to take Jeremy Alcede into custody and hold him until he purges himself of all contempt by fully complying with this Order; and it is further

ORDERED that this Court will hold a status conference at 10:30 a.m. on April 9, 2015 in order to determine whether Jeremy Alcede has complied with this Order; and it is further

ORDERED that this hearing shall take place in Courtroom 600, 6th Floor, Bob Casey Federal Courthouse, 515 Rusk Street, Houston, Texas; and it is further

ORDERED that Jeremy Alcede and John Boyert shall personally appear at the status conference to be held at 10:30 a.m. on April 9, 2015, in order to give testimony that all of the actions required by this Order have, in fact, been taken; and it is further

ORDERED that if Jeremy Alcede fails to personally appear at the status conference scheduled for 10:30 a.m. on April 9, 2015, then he shall be in contempt of this Order, and this Court will issue a bench warrant for the U.S. Marshals Service to take Jeremy Alcede into custody and produce him in this Court; and it is further

ORDERED that if John Boyert fails to personally appear at the status conference scheduled for 10:30 a.m. on April 9, 2015, then he shall be in contempt of this Order, and this Court will issue a bench warrant for the U.S. Marshals Service to take John Boyert into custody and produce him in this Court
